Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue any writ or order or direction more particularly one in the nature of writ of mandamus, declaring the action of the respondents in not allocating the CMR paddy to the petitioner industry on par with the other millers as non-application of mind, illegal, void, arbitrary, null and unconstitutional and consequently direct the respondents to allocate paddy for Custom Milling Rice (CMR) to the petitioner for all seasons on par with other rice mills on regular basis

W.P.No.12481 of 2021

ORDER:

This Writ Petition is filed seeking to issue a Writ of *Mondamus* declaring the action of the respondents in not allocating the paddy for Custom Milling Rice to the petitioner-rice mill, on par with the other mill, as illegal, void and arbitrary and consequently, to direct the respondents to allocate paddy for Custom Milling Rice to the petitioner for all seasons on par with other rice mills.

Heard Sri Amancharla V.Gopal Rao, learned counsel for the petitioner, and Sri A.Jagan, learned Standing Counsel appearing for the respondents.

It has been contended by the petitioner that it is a rice mill situated at Manakonduru Village, Karimnagar District; that in respect of other rice mills, the respondents are supplying paddy for Custom Milling Rice; that the respondents are not allocating the paddy for Custom Milling Rice to it; and that therefore, it has submitted several representations to the respondents on 03.12.2020, 27.01.2021 and 18.5.2021 for allocating paddy for Custom Milling Rice to it.

The grievance of the petitioner is that the respondents have so far, not passed any orders on the representations submitted by it for allocation of paddy for Custom Milling Rice.

Learned counsel for the petitioner contended that appropriate orders be passed in the Writ Petition directing the respondents to consider the representations submitted by the petitioner and pass appropriate orders in accordance with law.

Learned Government Pleader for Civil Supplies appearing for the respondents fairly submitted that the respondents would consider the representations submitted by the petitioner and pass appropriate orders in accordance with law.

This Court, having considered the submissions made by the learned counsel for both the parties, is of the considered view that this Writ Petition can be disposed of directing the respondents to consider the representations submitted by the petitioner on 03.12.2020, 27.01.2021 and 18.5.2021 and pass appropriate orders in accordance with law, as expeditiously as possible, preferably within a period of four weeks from the date of receipt of a copy of this order.

With the above directions, the Writ Petition is disposed of.

Miscellaneous petitions, if any, pending shall stand closed.


