Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue an appropriate Writ, Order or Direction, more particularly one in the nature of Writ of Mandamus, to declare action of the 3rd Respondent in cancelling the allotment of Quarter No.AE/48, Hill Colony, Nagarjuna Sagar which is in the possession of the petitioner since date of allotment i.e., 21/09/2007 by allotting to the 6th Respondent on the ground that it was sublet and violation of allotment rules though he never given sublet and violated any rules of allotment of quarter to the employees of the Nagarjuna Sagar Project is as being illegal, arbitrary, and unconstitutional and for other reliefs and violation of article 21 and 300-A of constitution of India and consequently set aside the memo dated 14/07/2021.

ORDER:

Heard the learned counsel for the petitioner, the learned Government Pleader for Irrigation & CAD, and M/s.A.Deepthi, learned Standing Counsel for TSGENCO, for the respondents. With their consent, the Writ Petition is disposed of at the stage of admission itself.

Aggrieved by the action of the respondent No.3 in cancelling the allotment of quarter No.AE/48, Hills Colony, Nagarjuna Sagar, which is in possession of the petitioner since 21.09.2007, and allotting the same in favour of respondent No.6, the present writ petition is filed.

Learned counsel for the petitioner states that neither any notice was issued nor an opportunity of hearing was afforded to the petitioner before cancelling the allotment of quarter made in his favour.

Having considered the photographs as well as the Discharge Summary Certificate issued by the Gandhi Hospital, Secunderabad, filed by the petitioner along with the writ petition, which show that the petitioner was suffering from Covid-19 and hospitalized for the treatment of the same, and also having regard to the fact that no prior notice was issued to the petitioner before cancelling the allotment of quarter, the Writ Petition is allowed and the Memo dated 14.07.2021 issued by respondent No.3, whereby the allotment of quarter made in favour of the petitioner was cancelled, is hereby set aside. In case the official respondents intend to take any further action against the petitioner, they shall do so only after putting the petitioner on notice, calling for his

explanation, passing a speaking order thereon and communicating a copy thereof.

The miscellaneous petitions pending, if any, shall stand closed. There shall be no order as to costs.
