Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue a Writ, Order or Direction; more particularly, one in the nature of Writ of "Mandamus" declaring the action of the respondents herein in not treating the 2nd petitioner institution as a Muslim minority educational institution in accordance with the guidelines issued in G.O.Ms No.1 dated 16.1.2004 and thereafter not considering the petitioners' request made vide its application dated 23.06.2014 as illegal, arbitrary and unconstitutional and consequently direct the respondents to treat the 2nd petitioner institution as a Muslim minority institution for the future academic years from 2014-15 and permit the 2nd Petitioner institution to make admissions as a Minority Educational Institution.

Petition under Section 151 CPC praying that in the circumstances stated in the affidavit filed in support of the petition, the High Court may be pleased to direct the Respondents to forthwith pass orders on the application of the Petitioners' dated 23.06.2014 to include the 2nd institution under the category of Muslim Minority

Educational Institutions for the purpose of admissions in the counseling process for the academic year 2014-15 and beyond and also permit the 2nd Petitioner to make admissions as a Muslim minority educational institution, pending the disposal of the writ petition.
