Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue an order or direction more particularly one in the nature of Writ of Mandamus declaring the action of 2nd respondent in issuing the order dated 28/09/2020 and 06/10/2020 in directing the 5th respondent Grampanchayat to conduct fresh auction of fishing rights in respect of Jalakam Cheruvu of Kothapally Grampanchayat, Balmoor Mandal, Nagarkurnool District, though the 5th respondent have already held auction of fishing rights of the said Cheruvu in favour of the petitioner in pursuant to the earlier order of the 2nd respondent dated 06/08/2020, as illegal unlawful and against the principles of natural justice and consequently direct the respondents to Continue the fishing rights of the Jalakam Cheruvu of Kothapally Village for the year 2020-21 at the bid amount of Rs.40,000/-.
