Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to pass an order or direction more particularly one in the nature of writ of mandamus or any other appropriate writ or direction, holding that the inaction of the Respondents No.2 to 4 in not disposing the claim of the Petitioner vide representations dated 07-10-2020, 21-10-2020 AND 06/11/2020 and not referring the claim of the Petitioner to the civil court in file No.G/363/2020 dated 28-02-2020 to the extent of the land of the Petitioner in Sy.No.372, Sy.No.377 and Sy.No.381 is illegal, arbitrary, politically motivated, against the provisions of Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act 2013, against the principles of natural justice and fair play and violative of Article 14, 19, 21 and 300-A of the Constitution of India and consequently direct the Respondents No.2 to 4 to refer the claim of the Petitioner to the Civil Court in file No.G/363/2020 dated 28-02-2020 to the extent of the land of the Petitioner covered by Sy.No.372 admeasuring Ac.00-18 gts., Sy.No.377 admeasuring Ac.00-24 1/2 gts. and Sy.No.381 admeasuring Ac.00-12 gts. of Thadur Village, Thangallapalli Mandal, Rajanna Sircilla District.

Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue writ order or direction more particularly one in the nature of writ of mandamus declaring the action of the respondents in non paying the compensation for the acquired lands of the petitioner in survey No. 372/E extent ac 0.16 gts, in survey No. 377/E extent Ac 0.30 gts and in survey No. 381/E extent ac 0.13 gts sitauted at Thadur village, Thangallapally Mandal, Rajanna Sircilla District even though award (order) vide Proc No. A1/710/2020 dated 26/3/2020 passed by the respondent No.3 and even after the petitioner made representation on 5/11/2020 and also claim of the respondent No. 5 was rejected vide memo No. A/710/2020 dated 25/11/2020 as arbitrary and illegal and contrary to the provisions of the Right to Fair, Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement, Act 2013.

Petition under Section 151 CPC praying that in the circumstances stated in the affidavit filed in support of the petition, the High Court may be pleased to direct the respondents to consider the representation dated 5/11/2020 and thereby to pay the compensation for the acquired lands in survey No. 372/E extent ac 0.16 gts, in survey No. 377/E extent Ac 0.30 gts and in survey No. 381/E extent ac 0.13 gts sitauted at Thadur village, Thangallapally Mandal, Rajanna Sircilla District in pursuance of the award (order) vide Proc No. A1/710/2020 dated 26/03/2020 passed by the respondent No.3 pending disposal of the above writ petition.

WRIT PETITION Nos.21088 of 2020 and 13452 of 2021

COMMON ORDER:

W.P.No.21088 of 2020 is filed questioning the inaction of respondent Nos.2 to 4 in not disposing the claim of the petitioner *vide* representations dated 07.10.2020, 21.10.2020 and 06.11.2020 and not referring his claim to the Civil Court, whereas W.P.No.13452 of 2021 is filed questioning the inaction of the respondents in paying the compensation amount to the petitioner in respect of the acquired lands, despite passing Award dated 26.03.2020 by the respondent No.3.

The learned Government Pleader for Land Acquisition has stated that the cause in W.P.No.21088 of 2020 does not survive, as the official respondents have already rejected the claim of the petitioner in W.P.No.21088 of 2020, duly taking into consideration the objections filed by him. The learned Government Pleader has further stated that due to the pendency of W.P.No.21088 of 2020, the compensation amount, as per the Award dated 26.03.2020, could not be paid to the petitioner in W.P.No.13452 of 2021, and that the authorities will take steps to pay the compensation to the petitioner in W.P.No.13452 of 2021 at the earliest.

Having regard to the above made submissions, the grievance of the petitioners in both the writ petitions stand redressed.

The writ petitions are, accordingly, disposed of. However, liberty is granted to the petitioner in W.P.No.21088 of 2020 to approach the appropriate forum seeking appropriate relief if he has any grievance.

The miscellaneous petitions pending, if any, shall stand closed.

There shall be no order as to costs.
