The Court made the following: ORDER

CRIMINAL PETITION No.7229 OF 2021

ORDER:

This Criminal Petition, under Section 482 of the Code of Criminal Procedure, 1973, is filed by the petitioners/A2 to A4, to quash the proceedings in Crime No.108 of 2021 of Addakal Police Station, Mahabubnagar District, registered for the offences punishable under Sections 504 and 505(2) of IPC.

2. Heard the learned counsel for the petitioners/A2 to A4, the learned Assistant Public Prosecutor representing respondent No.2-State and perused the record.

3. Learned counsel for the petitioners/A2 to A4 would submit that though this Criminal Petition is filed to quash the proceedings against the petitioners/A2 to A4 in Crime No.108 of 2021 of Addakal Police Station, Mahabubnagar District, he restricts the prayer seeking a direction to the investigating agency to follow the procedure prescribed under Section 41A of Cr.P.C. and to follow the guidelines prescribed by the Apex Court in **Arnesh Kumar v. State of Bihar and another**¹.

4. The learned Assistant Public Prosecutor representing the respondent No.2-State conceded the request of the learned counsel for the petitioners/A2 to A4.

5. Under these circumstances, the Station House Officer, Addakal Police Station, Mahabubnagar District, is directed to follow the procedure laid down under Section 41A of Cr.P.C. before

arresting the petitioners/A2 to A4 and strictly adhere to the guidelines formulated by the Apex Court in **Arnesh Kumar v, State of Bihar**'s case *supra*.

6. With the above direction, the Criminal Petition is disposed of.

Miscellaneous Petitions, if any, pending in this Criminal Petition shall stand closed.
