Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue an appropriate writ order or direction more particularly one in the nature of writ of Mandamus by calling for the records relating to and connected with Letter No.1928/ACP/C5/GHMC/2009 dt. 16-12-2009 and set aside the same holding it absolutely illegal, arbitrary unconstitutional and violative of Article 14 and 21 of Constitution of India and also violative of judgment and Decree in A.S.No.191 of 2002 dt. 15-10-2003 passed by X Additional Chief Judge, City Civil Court, Hyderabad and consequently direct the respondents to consider the application of the petitioner under Building penalization Scheme and pass appropriate orders by regularizing the construction of additional room made by the petitioner in Flat No.3 Block No.43 situated at Bahadurpura Housing Board Colony, Hyderabad in terms of the Judgment and Decree passed in A.S.No.91 of 2002 on the file of X Additional Chief Judge, City Civil Court, Hyderabad dt. 15-10-2003.
