Petition under Sections 437 & 439 of Cr.P.C, praying that in the circumstances stated in the grounds filed in support of the Criminal Petition, the High Court may be pleased to release the petitioner on bail in Crime No.160 of 2020 on the file of Police Station Parkal, Warangal Rural District.

The petition coming on for hearing, upon perusing the Petition and the grounds filed in support thereof and upon hearing the arguments of Sri.A.Prabhakar Rao, Advocate for the Petitioner and PUBLIC PROSECUTOR (TG) for the Respondent, the Court made the following.

ORDER

This Criminal Petition, under Section 439 of the Code of Criminal Procedure, 1973, is filed by the petitioner/A1 for grant of bail in Crime No.160 of 2021 of Parkal Town Police Station, Warangal District, registered for the offences punishable under Sections 498A and 306 read with 34 of I.P.C.

2. Heard both sides. Perused the record.

3. In the course of submissions, it is brought to the notice of this Court that A2 and A3 in the subject crime were granted regular bail by the Court of Session. The petitioner/A1 is in judicial custody since 24.07.2021. Most part of the investigation is completed. Under these circumstances, this Court is inclined to grant bail to the petitioner/A1 on some conditions.

4. Accordingly, the petitioner/A1 is ordered to be released on bail, subject to the following conditions:

(i) The petitioner/A1 shall execute a personal bond for a sum of Rs.25,000/- (Rupees twenty five thousand only) with two sureties in a like sum each to the satisfaction of the learned Judicial Magistrate of First Class, Parkal.

(ii) After release on bail, the petitioner/A1 shall appear before the Station House Officer, Parkal Town Police Station, Warangal District, on every Thursday and Saturday between 10:00 AM and 12:00 Noon till filing of charge sheet.

(iii) During the bail period, the petitioner/A1 shall not indulge in any crime.

(iv) The petitioner/A1 shall not, directly or indirectly, meddle with the investigation, intimidate or induce the witnesses, tamper the evidence and he shall co-operate with the Investigating Officer for smooth completion of the investigation.

5. This Criminal Petition is, accordingly, allowed.

Miscellaneous petitions, if any, pending in this Criminal Petition, shall stand closed.
