Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to grant an appropriate Writ order or direction more particularly one in the nature of Writ of mandamus to declare the action of the official Respondents no.2 and 3 in not implementing the name of the petitioner and not issuing of the online pass book in favour of the petitioner and as per the order dated 20-02-2019 vide proceedings No.B/1539/2013 issued by the Tahsildar, Mogudampally in respect of the agricultural lands in Sy.no.64/AA/1/A extent Ac.0-20gts., out of Ac.1-00gts., situated at Mugudampally village, Zaheerabad Mandal, Medak District, now Sangareddy District is arbitrary, illegal, UN-constitutional and against the rules of Telangana Rights in Land and Pattedaar Pass Books Act, 2020 and consequently direct the official Respondents no.2 and 3 to implement the orders in respect of the agricultural land in aforementioned survey number.

Petition under Section 151 CPC praying that in the circumstances stated in the affidavit filed in support of the petition, the High Court may be pleased to direct the official Respondents No.3 to insert the name of the petitioner in revenue records as per dharani portal and issue the e-pass book for the land in Sy.no.64/AA/1/A extent Ac.0-20 gts., out of Ac.1-00gts., situated at Mugudampally village, Zaheerabad Mandal, Medak District, presently Sangareddy District.

WRIT PETITION No.24018 of 2021

ORDER:

Heard the learned counsel for the petitioner and the learned Government Pleader for Revenue for the respondents. With their consent, the Writ Petition is disposed of at the admission stage.

2. This writ petition is filed questioning the inaction of respondent Nos.2 and 3 in implementing the name of the petitioner and issuing online passbook in favour of the petitioner, as per the order dated 20.02.2019, passed by the Tahsildar, Mogudampally Village, in respect of the agricultural land, admeasuring Ac.0.20 guntas out of Ac.1.00 guntas, in Survey No.64/AA/1A, situated at Mogudampally Village, Zaheerabad Mandal, Medak District, now Sangareddy District.

3. Learned counsel for the petitioner has stated that the petitioner has already made an application through *online* in Dharani Portal on 10.02.2021 *vide* Application No.73373 ventilating his grievance. But, so far, no action has been taken thereon.

4. Learned Government Pleader, on instructions, has stated that the respondent authorities will consider the application of the petitioner and pass necessary orders thereon, in accordance with law.

5. In view of the above made submission, without going into the merits or demerits of the case, the Writ Petition is disposed of directing the respondent authorities to consider the online application of the petitioner, dated 10.02.2021, and pass necessary

orders thereon, strictly in accordance with law, as expeditiously as possible, preferably, within a period of eight weeks from the date of receipt of a copy of this order, duly putting all the interested parties on notice and considering the objections, if any.

Pending miscellaneous petitions, if any, shall stand closed.

There shall be no order as to costs.
