Petition under Section 437 & 439 of Cr.P.C, praying that in the circumstances stated in the grounds filed in support of the Criminal Petition, the High Court may be pleased to release the petitioner on bail pending, trial and enquiry in Crime No. 386 of 2019 of Nacharam Police Station, Ranga Reddy District, Telangana State

The petition coming on for hearing, upon perusing the Petition and the grounds filed in support thereof and upon hearing the arguments of SRI Dr CHALLA SRINIVASA REDDY Advocate for the Petitioner and Assistant PUBLIC PROSECUTOR for the Respondent, the Court made the following.

ORDER:

ORDER:

This Criminal Petition, under Sections 437 and 439 of the Code of Criminal Procedure, 1973, is filed by the petitioner/accused seeking to grant bail to him in connection with Crime No.386 of 2019 of Nacharam Police Station, Rachakonda, registered for the offences punishable under Sections 354, 323 and 506 of I.P.C. and Section 11 read with Section 12 of the Protection of Children from Sexual Offences Act, 2012.

Heard the learned Counsel appearing for the petitioner, learned Assistant Public Prosecutor appearing for the respondent-State and perused the record.

Learned counsel for the petitioner would submit that in an earlier occasion also the *de facto* complainant filed similar complaint on same set of facts and the same was registered as a case in Crime No.506 of 2018 and pending investigation in the said case a compromise petition was filed vide Criminal Petition No.781 of 2019, which is pending for consideration. He further submits that at the instigation of the father, brothers and brothers-in-law of the mother of the *de facto* complainant, she lodged the present complaint. He further submits that the petitioner has been in custody since 13.12.2020 and that the petitioner is ready to abide by any condition that may be imposed by this Court in the event of his enlargement on bail.

Learned Assistant Public Prosecutor though opposed the bail application, but conceded to the facts with regard to the registration of Crime No.506 of 2018 on the complaint lodged by the *de facto* complainant and the petitioner is languishing in jail since 13.12.2020.

Having regard to the facts and circumstances of the case and in view of the fact that the petitioner/accused is in judicial custody since 13.12.2020, without adverting to the merits of the case, I am inclined to grant bail to the petitioner/accused.

The Criminal Petition is allowed and the petitioner/accused is directed to be released on bail, subject to the following terms and conditions:

- (i) The petitioner/accused shall be released on bail on his executing a personal bond to the tune of Rs.25,000/- (Rupees twenty five thousand only) with two sureties for a like sum each to the satisfaction of the IV Additional Metropolitan Magistrate-cum-IV Additional Junior Civil Judge, L.B.Nagar, Ranga Reddy District.
- (ii) The petitioner/accused shall not interfere with the investigation and shall cooperate with the investigating agency.
- (iii) The petitioner/accused shall personally appear before the Investigating Officer concerned on each alternate day between 10.00 a.m. and 2.00 p.m., till completion of the investigation.
- (iv) The petitioner/accused shall not misbehave, coerce, intimidate, terrorize or otherwise threaten the *de facto* complainant and her sister and if it is found that the petitioner/accused is indulged in similar type of activities or threaten, coerce or intimidate the *de facto* complainant and her sister in future during pendency of the present case and previous case, the liberty granted to the petitioner shall automatically stands cancelled and he shall be taken into custody forthwith.
