
**COMMON ORDER:** (*Per the Hon'ble the Chief Justice Hima Kohli*)

1. In the present batch of writ petitions, the grievance raised by the petitioners against the respondent/GHMC is that though they have applied for regularization of buildings situated in Tatanagar and Rajendranagar of Ranga Reddy District, the respondents have issued notices proposing to demolish their properties without deciding the said applications.
2. Mr. Pasham Krishna Reddy, learned Standing Counsel for the respondent/GHMC states that the Corporation shall not take any coercive steps pursuant to the demolition notices issued to the petitioners herein till their building regularization applications are decided one way or the other. However, the petitioners be restrained from raising any further construction on the subject properties.
3. It is deemed appropriate to close the present petitions while binding the respondent/GHMC to the statement recorded hereinabove to the effect that till the BRS applications filed by the petitioners and pending with the respondent/GHMC are disposed of, no steps shall be taken to demolish the buildings erected on the subject premises, in terms of the impugned demolition notices. Needless to state that if the respondent/GHMC rejects the building regularization applications

filed by any of the petitioners, they shall be entitled to seek appropriate legal recourse. To ensure that the petitioners do not misuse the concession given by the respondent/GHMC, GHMC shall videograph the constructions existing on the premises of the petitioners. The said process shall be completed within two weeks and made a part of the record. Further, the petitioners in each case shall file their affidavits within one week undertaking *inter alia* that they shall not raise any further construction on the subject premises till their BRS applications are decided by the respondent/GHMC. Copies of the affidavits shall be duly served on the learned Standing Counsel for the respondent/GHMC.

4. With these orders, the present petitions are disposed of along with the pending applications, if any.


