Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue an appropriate Writ. Direction or Order, particularly one in the nature of Writ of Mandamus declaring the action of the Respondent No.1 in not considering the candidature of the Petitioner as illegal, arbitrary and violative of principles of natural justice and consequently direct the Respondents to expeditiously complete the selection process for the post of Director, NATMO and appoint the Petitioner.

## HON'BLE SELJUSTICE ABHINAND KUMAR SHAVILI W.P.No.27400 of 2021

#### ORDER:

This Writ Petition is filed seeking a Writ of Mandamus declaring the action of the 1st respondent in not considering the candidature of the petitioner as illegal and arbitrary and consequently direct the respondents to expeditiously complete the selection process for the post of Director, National Atlas and Thematic Mapping Organization (NATMO) and appoint the petitioner as Director, NATMO.

- Heard Sri Kowturu Pavan Kumar, learned counsel for the petitioner and Sri B.Jithender, learned Standing Counsel for Central Government, appearing for the respondents.
- 3. It has been contended by the petitioner that he is fully eligible and qualified to be appointed to the post of Director in NATMO and the respondents have issued notification for filling up the post of Director on 21-12-2020 and petitioner has responded to the said notification. The grievance of the petitioner is that though the petitioner fulfils the eligibility criteria, the respondents have not considered his case for appointment to the post of Director, NATMO. Challenging the same, the present Writ Petition is filed.
- Lea ned counsel for the petitioner has contended that a perusal of the eligibility criteria discloses that one must possess

Master Degree from a recognized university and that the petitioner is having recognized qualification and in spite of the same, the respondents have not considered the case of the petitioner for the post of Director, NATMO.

- 5. Learned Standing Counsel for the respondents, on instructions, has submitted that the petitioner is not fulfilling the eligibility criteria as specified in the notification. The eligibility criteria categorically states that one most hold the analogous post on regular basis in the parent cadre or department. Admittedly, the petitioner is not holding any regular post. The case of the petitioner was considered, but however, since the petitioner was not coming within the zone of consideration, the case of the petitioner was not considered for appointment. Therefore, there are no merits and that the Writ Petition is liable to be dismissed.
- 6. Having regard to the rival submissions made by the parties, this Court is of the considered view that the petitioner is not fulfilling the eligibility criteria as specified in the notification issued by the respondents. Hence, the respondents have rightly not considered the case of the petitioner for appointment to the post of Director, NATMO.
- Therefore, there are no merits in the Writ Petition and the same is liable to be dismissed.
  - 8. Accordingly, the Writ Petition is dismissed. No costs.

As a sequel, the miscellaneous petitions pending, if any,

shall stand closed.
