Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue a Writ of Mandamus or any other appropriate Writ, Order or Orders, Direction or Directions to direct the 2nd and 3rd respondents to act in accordance with law and to rectify the error in not implementing the proceedings of the 3rd respondent in No.B/978/2015 dated 21/04/2015 causing mutation in favour of the petitioner and 4 others in respect of the land in Sy.Nos.36, 36/A and 36/A1 of Fouzpur Jainath Mandal, Gramapanchayat Taroda (B), Adilabad District by considering the representation dated 24/06/2021.

Petition under Section 151 CPC praying that in the circumstances stated in the affidavit filed in support of the petition, the High Court may be pleased to direct the 2nd respondent to rectify the error in not implementing the proceedings of the 3rd respondent in No.B/978/2015 dated 21/04/2015 causing mutation in favour of the petitioner and 4 others in respect of the land in Sy. Nos. 36, 36/A and 36/A1 of Fouzpur Village, Jainath Mandal, Gramapanchayat Taroda (B), Adilabad District, by considering the representation dated 24/06/2021, pending disposal of the Writ Petition.

**WRIT PETITION No. 30984 of 2021**

**ORDER:**

Heard the learned counsel for the petitioner and the learned Government Pleader for Revenue appearing for the respondents. With their consent, this Writ Petition is being disposed of at the admission stage.

Questioning the action of respondent Nos.2 and 3 in not implementing the proceedings dated 21.04.2015 issued by respondent No.3 for causing mutation in favour of himself and four others with respect to the subject land situated at Fouzpur Village, Jainath Mandal, Gram Panchayat Taroda (B), Adilabad District, in spite of representation dated 24.06.2021, the petitioner filed this Writ Petition.

The learned Government Pleader for Revenue states that if the petitioner makes an application through online in Dharani Portal, the same would be considered and necessary orders would be passed by the authorities concerned in accordance with law.

Having regard to the above made submission, without going into the merits or demerits of the case, this Writ Petition is disposed of directing the petitioner to make an application for implementation of the proceedings dated 21.04.2015 issued by

respondent No.3 for causing mutation in favour of himself and four others with respect to the subject property, through online in Dharani Portal, within a period of two (2) weeks from the date of receipt of a copy of this order. On such application being filed, the authorities concerned shall pass necessary orders thereon strictly in accordance with law, as expeditiously as possible, preferably, within a period of eight (8) weeks thereof, duly taking into consideration the proceedings dated 21.04.2015 issued by respondent No.3 and putting all the interested parties on notice and considering their objections, if any.

Miscellaneous applications, if any pending, shall stand closed. There shall be no order as to costs.
