Bounded by North 1-9-252/13 South 30 Wide road East 40 Wide road West H.No. 1-9-209/4/A. Without insisting upon occupancy Certificate from the 4th respondent by holding that the refusal to provide electricity connection to the above referred premises as illegal and arbitrary.

Tower, Ramnagar, Musheerabad, Hyd. And bounded by North 1-9-252/13 South 30 Wide road East 40 Wide road West H.No. 1-9-209/4/A. Without insisting upon occupancy certificate from 4th respondent pending disposal of main writ petition and deem fit and proper in the circumstance of the case.

ORDER:

Heard counsel for the petitioner, Sri R. Vinod Reddy, learned Standing Counsel for Telangana State Southern Power Distribution Corporation Limited, appearing for respondents 1 to 3, and Sri P.Krishna Reddy, learned Standing Counsel appearing for respondent No.4.

2. It is stated by learned Counsel appearing for the petitioner as well as Sri R. Vinod Reddy, learned Standing Counsel appearing for respondent Nos.1 to 3 that the issue in this Writ Petition is covered by the orders of this Court dt.23.03.2018 in W.P. No.9789 of 2018 and dt.19.11.2021 in WP.No.26418 of 2021.

3. Therefore, for reasons alike, this Writ Petition is also disposed of with a direction to the respondents to release the power supply to the premises of the petitioner subject to the compliance of the terms and conditions and on furnishing an undertaking to produce the Occupancy Certificate from the concerned Municipal Corporation within a prescribed period, and if no such Occupancy Certificate is produced within such period, it is open to the respondents to take appropriate action in accordance with law. There shall be no order as to costs.

4. Miscellaneous petitions, if any, pending in this writ petition shall stand closed.


