Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue a Writ Order or direction more particularly one in the nature of Writ of Mandamus declaring the action of the Respondents No. 4 in refusing to receive register and release the sale deed or sale deeds presented by the Petitioners vide Plots in Survey Nos. 12/part and 13/part, situated at Balapur village and Mandal (earlier Saroornagar Mandal), Ranga Reddy District pursuant to the MEMO No G2/257/2019, dated 26-8-2020, issued by the office of the Respondent No.2, under prohibition of registration of unauthorized plots and buildings against the Petitioners plots made out in sanctioned layout, issued by the Balapur gram panchayat, as arbitrary illegal without any jurisdiction contrary to the provisions of the registration Act 1908 and in violation of Article 14 of Constitution of India and consequently direct the Respondent No. 4 herein to receive register and release the sale deeds presented by the Petitioner in respect of Plots in Survey Nos. 12/part and 13/part, situated at Balapur village and Mandal (earlier Saroornagar Mandal), Ranga Reddy District without reference to MEMO No.G2/257/2019, dated 26-08-2020, issued by the office of the Respondent No.2 and grant.

Petition under Section 151 CPC praying that in the circumstances stated in the affidavit filed in support of the petition, the High Court may be pleased to direct the respondent No. 4 to receive register, and release the sale deeds presented by the petitioner in respect of the plots in Survey Nos. 12/part and 13/part, situated at Balapur village and Mandal (earlier Saroornagar Mandal), Ranga Reddy District without reference to MEMO No.G2/257/2019, dated 26-08-2020, issued by the office of the Respondent No.2 and grant.
