Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue order or direction more particularly writ in the nature of Mandamus the action Hon'ble Debt Recovery Tribunal- Hyderabad-I not registering SA after compliance the condition order passed in L.A.No.874 of 2021 in SA SR.No.391 dated 28/10/2021, is arbitrary illegal and violative of principles of natural justice and also in violative of Article 300-A. Consequently direct the Registrar Debet Recovery Tribunal, Hyderabad-I to registered the SA.

**ORDER:** (*Per Hon'ble Sri Justice Ujjal Bhuyan*)

Heard Mr. V. Srikantha Rao, learned counsel for the petitioner.

2. Aggrieved by the notice dated 28.04.2021 issued by respondent Nos.2 and 3/Union Bank of India under Section 13(4) of the Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest Act, 2002 (briefly, the SARFAESI Act hereinafter) petitioner has filed securitization application under Section 17 of the SARFAESI Act before the Debts Recovery Tribunal-I, Hyderabad (Tribunal). Since there was delay in filing the said application, petitioner filed an interlocutory application, being I.A.No.874 of 2021 for condonation of delay. From the order dated 28.10.2021 (page 69 of the paper book), it is seen that I.A.No.874 of 2021 was allowed subject to payment of costs of Rs.1,000/- in favour of Prime Minister's National Relief Fund.

3. We find that petitioner has paid the said demand through demand draft and there is an acknowledgment by the Tribunal that the above condition has been complied with.

4. Grievance of the petitioner is that the securitization application has not yet been registered despite condonation of delay. It has been simply numbered as S.A (IR) No.391 of 2021. Having regard to the above, a direction is issued to the Registrar of the Tribunal to register

the securitization application filed by the petitioner and thereafter to place it before the Tribunal for proceeding in accordance with law.

5. Writ petition is, accordingly, disposed of.
6. Miscellaneous applications, if any pending, shall stand closed.
7. No costs.
