**HON'BLE MR. JUSTICE CHANDRA KUMAR SONGARA**

**Order****30/04/2021**

These bail applications have been filed under Section 439 Cr.P.C in connection with FIR No. 146/2021, registered at Police Station Pilani, District Jhunjhunu for the offences under Sections 457 and 380 of IPC.

Learned counsel for the petitioners have submitted that petitioners Abhishek @ Kalu @ Tiger and Ghanshayam @ Pankaj are in judicial custody since 04.04.2021 and petitioner Akash Dokwal @ Bittu is in judicial custody since 08.04.2021. Petitioner Abhishek @ Kalu @ Tiger has no criminal antecedents. As per rejection bail order, petitioner Ghanshayam @ Pankaj has criminal antecedents of two cases out of which one case has been disposed of and other case is still pending. Petitioner Akash Dokwal @ Bittu has criminal antecedents of one case. Hence, the petitioners may be released on bail.

Learned Public Prosecutor has opposed the bail application.

Considering the submissions made by learned counsel for the petitioners and taking into consideration overall facts and circumstances of the case but without expressing any opinion on the merits/demerits of the case, this court deems it just and proper to enlarge the petitioners on bail.

Accordingly, the bail applications under Section 439 Cr.P.C. are allowed and it is ordered that the accused-petitioners Abhishek @ Kalu @ Tiger son of Shri Manoj, Ghanshayam @ Pankaj son of Shri Babulal and Akash Dokwal @ Bittu son of Shri Suresh Dokwal shall be enlarged on bail provided each of them
