This anticipatory bail application has been filed under Section 438 Cr.P.C. in connection with FIR No. 71/2021, registered at Police Station Sooroth, District Karauli for the offences under Sections 143, 323, 341, 354, 451 and 379 of IPC.

Learned counsel for the petitioners submits that prior to registration of impugned FIR, the husband of the prosecutrix and his family members committed offence of kidnapping etc. FIR No. 73/2021 to this effect has been registered for the offences under Sections 363, 366 and 376DA as well as under Sections 3, 4, 16 and 17 of the POCSO Act, 2012. On 15.02.2021, family members

of the complainant committed serious offence towards the family members of the petitioners for which an FIR bearing No. 76/2021 has also been registered against the family members of the complainant. Counsel contends that, just to create pressure upon the petitioners, the complainant lodged the alleged FIR. Counsel further submits that the petitioner Nos. 1 and 2 are senior citizens aged about 70 years and Co-accused Balraj has already been granted anticipatory bail by the coordinate bench of this Court vide order dated 06.04.2021. Hence, the anticipatory bail of the petitioners may be granted.

On the other hand, learned Public Prosecutor has opposed the bail application.

Taking into consideration the submissions made by the learned counsel for the petitioners and looking to the facts and circumstances of the case but without expressing any opinion on the merits and demerits of the case, I deem it just and proper to enlarge the petitioners on anticipatory bail.

Accordingly, this anticipatory bail application is allowed and it is ordered that in case of arrest of the petitioners Veersingh, Ramroop and Raman in FIR No. 71/2021, registered at Police Station Sooroth, District Karauli by the investigation officer, they shall be released on bail provided each of them furnishes a personal bond in the sum of Rs.50,000/- together with two sureties in the sum of Rs 25,000/- each to the satisfaction of concerned SHO/IO on the following conditions:

- i) That the petitioners will make themselves available for the investigation as and when required by the investigation officer.

- ii) That the petitioners will not leave India without permission of the Court.
- iii) That the petitioners will not temper with the evidence or threaten or pressurize the witnesses in the case.
