Mr. Mohammed Zubeir, Advocate has submitted that he has filed Vakalatnama on behalf of the complainant.

This anticipatory bail application has been filed under Section 438 Cr.P.C. in connection with FIR No. 56/2021, registered at Police Station Hindaun City, District Karauli for the offences under Sections 143, 323, 341, 336, 451 and 427 of IPC.

Learned counsel for the petitioners submits that the petitioners and complainant are family members and having a dispute. Counsel further submits that they have entered into compromise, so the complainant does not want to press the case against the petitioners. The fact of compromise has also been mentioned in rejection bail order. Hence, the anticipatory bail of the petitioners may be granted.

On the other hand, learned Public Prosecutor has opposed the bail application and learned counsel for the complainant submits that he has no objection if the anticipatory bail of the petitioners is granted.

Taking into consideration the submissions made by the learned counsel for the petitioner as well as learned counsel for the complainant and looking to the facts and circumstances of the case but without expressing any opinion on the merits and demerits of the case, I deem it just and proper to enlarge the petitioners on anticipatory bail.

Accordingly, this anticipatory bail application is allowed and it is ordered that in case of arrest of the petitioners, namely Lakhan Singh @ Lakhan Lal, Ramkhiladi, Sachin, Amar Singh, Dinesh and Smt. Kamla in FIR No. 56/2021, registered at Police Station Hindaun City, District Karauli by the investigation officer, they shall be released on bail provided each of them furnishes a personal bond in the sum of Rs.50,000/- together with two sureties in the sum of Rs 25,000/- each to the satisfaction of concerned SHO/IO on the following conditions:

- i) That the petitioners will make themselves available for the investigation as and when

required by the investigation officer.

ii) That the petitioners will not leave India without permission of the Court.

iii) That the petitioners will not temper with the evidence or threaten or pressurize the witnesses in the case.
