**HON'BLE MR. JUSTICE SANJEEV PRAKASH SHARMA**

**Order**

Learned counsel for the petitioners submits that the petitioners were given an extension up to 30.06.2021, however by a general order dated 25.05.2021 the services of Interns under the Young Intern Programme, 2016 have been dispensed with from 31.05.2021 which includes the petitioners also, whereas in case of the petitioners extension had already been granted up to 30.06.2021.

I have considered the submissions.

The petitioners as well as others were all appointed under a programme known as Young Intern Programme, 2016 Rajasthan State Pollution Control Board initially for a period of one year which was extended from time to time. However, the Pollution Control Board by the impugned order dated 25.05.2021 has terminated their services giving out reason that now they have regularly recruited JEE/JSOs who are posted in various offices and the workload shall be managed by them. A decision of such a nature cannot be faulted as it is based on administrative grounds. This Court also finds that there is no discrimination drawn by the Department. All the Interns have been commonly treated and have been now relieved.

In view thereof, no objection can be made and on the anvil of Article 14 so far as the contention of the petitioners is concerned of having been given extension up to 30.06.2021, this Court finds that such extension was given only to the petitioners while others had not been granted any such extension. No reasons for signaling out the petitioners come out in the order and the petitioners have been therefore, treated in similar fashion to others pertaining to the parity.

In view of above, I do not find any reason to interfere with the order impugned. The writ petition is devoid of merits and the same is accordingly dismissed.

All pending applications shall also stand disposed of.
