This anticipatory bail application has been filed under Section 438 Cr.P.C. in connection with FIR No. 492/2019 registered at Police Station Bandikui, District Dausa for the offences under Sections 420,467,468,471 and 120B of IPC.

Learned counsel for the petitioners submits that petitioner No.1 is a senior citizen of about 72 years of age, petitioner No.2 is aged about 50 years and petitioner No.3 is aged about 45 years, who are also ladies of old age. Bail application of co-accused Bablu @ Bhagwan Sahay under Section 439 CrPC has already been granted by the co-ordinate Bench of this Court. Petitioners have

no criminal antecedents. Hence, the anticipatory bail application of the accused-petitioners may be granted.

On the other hand, learned Public Prosecutor has opposed the bail application.

Considering the submissions made by the learned counsel for the petitioners and looking to the facts and circumstances of the case but without expressing any opinion on the merits and demerits of the case, I deem it just and proper to enlarge the petitioners on anticipatory bail.

Accordingly, this anticipatory bail application is allowed and it is ordered that in case of arrest of the petitioners-1.Ladbai W/o Basantilal, 2.Shakuntla D/o Kalyan and 3.Guddi D/o Kalyan in the aforesaid FIR, the accused-petitioners shall be released on bail; provided each of them furnish a personal bond in the sum of Rs.50,000/- with two sureties in the sum of Rs. 25,000/- each to the satisfaction of concerned SHO/IO on the following conditions:

- i) That the petitioners will make themselves available for the investigation as and when required by the investigation officer.
- ii) That the petitioners will not leave India without permission of the Court.
- iii) That the petitioners will not temper with the evidence or threaten or pressurize the witnesses in the case.
