These bail applications have been filed under Section 439 Cr.P.C. The petitioners have been arrested in connection with FIR No. 248/2020 registered at Police Station Vaishali Nagar, Jaipur (West) for the offence(s) under Sections 420, 406, 467, 468, 471 and 120B IPC.

Learned counsel for the petitioners submits that the petitioners have been falsely implicated in this case. They are behind the bars since long and conclusion of trial may take long time. Hence, the petitioners be enlarged on bail.

Learned Public Prosecutor as well as learned counsel for the complainant have opposed the bail applications.

Considering the contentions put-forth by the counsel for the petitioners and taking into account the facts and circumstances of the case and without expressing any opinion on the merits of the case, this court deems it just and proper to enlarge the petitioners on bail.

Accordingly, these bail applications under Section 439 Cr.P.C. are allowed and it is ordered that the accused-petitioners namely **(1) Shishram S/o Shri Dhannaram and (2) Rekharam S/o Late Shri Dungaram** shall be enlarged on bail provided each of them furnishes a personal bond in the sum of Rs.50,000/- with two sureties of Rs.25,000/- each to the satisfaction of the learned trial Judge for their appearance before the court concerned on all the dates of hearing as and when called upon to do so.
