**HON'BLE DR. JUSTICE PUSHPENDRA SINGH BHATI  
Order**

**30/09/2021**

In the wake of second surge in the COVID-19 cases,  
abundant caution is being maintained, while hearing the matters  
in Court, for the safety of all concerned.

Heard learned counsel for the parties and perused the material available on record.

The petitioners have been arrested in connection with FIR No.69/2021 of Police Station Mangrol, District Baran, for the offence punishable under Sections 420, 406, 467, 468, 471 & 120-B of IPC. They have preferred these bail applications under Section 439 Cr.P.C.

Learned counsel for the petitioners submits that the petitioners (1) Neeraj Yadav, (2) Mahesh Yogi & (3) Yashwant Mehta are in custody since 26.08.2021 and 24.08.2021 respectively and moreover, the allegations are pertaining to fraud in taking loan. Learned counsel for the petitioners submits that the names of petitioners are not there in the FIR.

Learned P.P. opposes the bail applications.

Having regard to the totality of the facts and circumstances of the case as also the fact that conclusion of the proceedings is likely to take some time and without expressing any opinion on the merits of the case, this Court deems it just and proper to grant bail to the accused petitioners under Section 439 Cr.P.C.


Accordingly, these bail applications filed under Section 439 Cr.P.C. are allowed and it is directed that petitioners **(1) Neeraj Yadav S/o Shri Devendra Yadav, (2) Mahesh Yogi S/o Shri Goverdhan Yogi & (3) Yashwant Mehta S/o Shri Hansraj,** shall be released on bail in connection with FIR No.69/2021 of Police Station Mangrol, District Baran provided each of them execute a personal bond in a sum of Rs.50,000/- with two sound and solvent sureties of Rs.25,000/- each to the satisfaction of learned trial court for their appearance before that court on each

and every date of hearing and whenever called upon to do so till the completion of the trial.
