Learned counsel for the petitioners undertakes to remove the defects within three weeks. In the eventuality of non-removal of defects within undertaken period, the office will place the matter before the Bench.



The petitioners are apprehending their arrest in a case registered for the offence punishable under Sections 147, 148, 149, 341, 323, 324, 307, 504, 506 of the Indian Penal Code and later on added Section 302 of the Indian Penal Code.

Petitioners are said to have assaulted the informant and his father by means of lathi-danda and Gadasa.

It is submitted by learned counsel for the petitioners that petitioners are innocent and have been falsely implicated in this case. He submits that there is case and counter case between the parties and both sides have sustained injury. He submits that there is specific allegation against co-accused Satish Yadav who assaulted on the head of the father of the informant by means of Gadasa, resultantly, father of the informant died during course of treatment. He submits that there is so many cases have been lodged against in between the petitioners and informant party each other. He further submits that petitioners have five criminal antecedent as stated in para-3 of this application.

Learned APP for the State opposes the prayer for bail

Considering the fact that there is specific allegation against co-accused Satish Yadav, the above named petitioners
