2      31-01-2022                      Learned counsel for the petitioners seeks permission to withdraw the petition of petitioner no.2, namely, Sanjay Kumar Jha @ Shankar Kumar Jha.

Permission is accorded.

Accordingly, the petition of petitioner no.2, namely, Sanjay Kumar Jha @ Shankar Kumar Jha is dismissed as withdrawn.

Heard learned counsel for the petitioners and learned APP for the State.

Learned counsel for the petitioners is expected to



honour his undertaking given in the instant case for depositing the requisite court fee and to remove the defect(s) as pointed out by the office when called upon to do so by the office.

The petitioners are apprehending their arrest in a case registered for the offences punishable under Sections 341, 323, 307, 379, 427, 504 and 506/34 of the Indian Penal Code.

It is a case of assault upon the informant and his family members by means of Bhala, farsa, rod and lathi by the accused persons.

It is submitted by learned counsel for the petitioners that the petitioners have falsely been implicated in this case. He further submits that there is case and counter case between the parties vide Annexure-2 to this petition. He further submits that there is no specific allegation of assault against these petitioners and specific allegation of assault is against co-accused Shankar Kumar Jha.

Learned APP appearing for the State has opposed the prayer for anticipatory bail.

In the facts and circumstances of the case, let the petitioner, no.1, namely, Praveen Kumar Jha, petitioner no.3, namely, Vinay Kumar Jha and petitioner no.4, namely, Sachin Kumar Jha, in the event of their arrest or surrender before the



court below within a period of four weeks from today, be released on anticipatory bail on furnishing bail bonds of Rs.10,000/- (ten thousand) each with two sureties of the like amount each to the satisfaction of learned Chief Judicial Magistrate, Madhubani in connection with Town P.S. Case No. 103 of 2020, subject to the conditions as laid down under Section 438(2) of the Cr.P.C.
