Heard Mr. Serto T. Kom, learned counsel appearing for the petitioners and Mr. H. Lenin, learned AG appearing for the State respondents.

As directed earlier by this Court, both the counsel for the parties submitted before this Court that out of 187 (one hundred and eighty seven) numbers of occupants, already 68 (sixty eight) numbers of occupants have already vacated the quarters and the quarters occupied by them have been already dismantled and as on today, only about 119 (one hundred and nineteen) occupants are occupying the Government quarters.

It is further submitted that out of 119 (one hundred and nineteen) occupants, 50 (fifty) are police personnel and 6 (six) are employees of JNIMS. In respect of 50 (fifty) police personnel and 6 (six) employees of JNIMS, they will be duly accommodated by the authorities at an early date and there will be no issue with regard to these 56 (fifty-six) occupants.

In respect of the remaining 63 (sixty-three) occupants, it has been submitted by learned AG as well as Mr. Serto, learned counsel for the petitioners that the Government has issued a Notice dated 07-06-2022 initiating the process to identify illegitimate employees who are occupying Government Quarters and during the process, it is anticipated that about 600 (six-hundred) vacant quarters will be available after completion of the said exercise and there will be plenty of vacant quarters available to accommodate the remaining 63 (sixty-three) petitioners.

In view of the above facts, learned AG submitted that the Government would need at least a month's time to complete the exercise for identifying vacant Government Quarters available at Langol Housing Complex and Lamphelpat. It is further submitted by learned AG that the present petitioners who have not avail any Government Quarters as on date will be accommodated on priority basis against the anticipated vacant quarters for which, the learned AG sought for granting one month's time to complete the process.

Mr. Serto T. Kom, learned counsel for the petitioners also fairly conceded that if the petitioners, who have not availed any Government Quarters as on today, are given accommodation against the anticipated vacant quarters on priority basis, they have no objection in disposing the present writ petition as suggested by the learned AG on behalf of the State respondents.

In view of the submission made above, the present writ petitions are disposed of by directing the respondents to complete the process of identification of the vacant Government

Quarters and to accommodate the petitioners who have not avail any Government Quarters as on today against the available vacant quarters on priority basis. It is made clear that the whole exercise be completed as early as possible preferably within a period of one month from today. It is further made clear that, till the aforesaid process is complete, the petitioners who have not avail any Government Quarters would be allowed to reside in their present quarters.

With the aforesaid directions, present writ petitions are disposed of.

Earlier interim orders stand vacated.
