ORDER

Heard Mr. M.U. Mahmud, learned counsel for the appellants. Also heard Mr. B. Kaushik, learned standing counsel, Education (Elementary) Department.

This appeal has been filed challenging the order dated 10.03.2022 passed in I.A.(C) 1090/2021 by which the learned Single Judge vacated the interim order dated 31.03.2021 passed in WP(C) 2282/2021, which was filed by the present appellants.

Initially the interim order was granted to the writ petitioners/present appellants by this Court in the said writ petition directing not to give effect to the provincialisation of services of respondent nos.7, 8 and 9. Subsequently, the private respondent nos.7, 8 and 9 moved the interlocutory application for vacating the interim order and the learned Single Judge by the impugned order vacated the interim order passed on 31.03.2021.

Since the impugned order is interlocutory in nature and the entire records of the matter are before the learned Single Judge and the subject matter is with regard to the provincialisation of services of the writ petitioners as well as the private respondent nos.7, 8 and 9, the matter has to be finally adjudicated by the learned Single Judge, we are therefore not inclined to interfere in the matter at this stage and we dispose of this appeal with a request to the learned Single Judge to decide the writ petition as expeditiously as possible.
