The learned counsel for the applicant submits that the connected appeal has already been admitted by order dated 24.04.2019. However, no notice was issued or stay was granted in the present application. Accordingly, he prays for impugned judgment and award dated 02.08.2016 passed in MAC case No. 1471/2014 be stayed. Objecting to such prayer, Mr. Dutta, learned counsel for the respondent Nos. 1 to 4 submits that the award may be stayed however subject to payment of 50% of the awarded amount before the Registry. The learned counsel for the appellant has also not objected to such prayer. Accordingly, the impugned judgment and award dated 02.08.2016 passed in MAC case No. 1471/2014 shall remain stayed till disposal of the connected appeal, however, subject to deposit of 50% of the awarded amount before the Registry of the court.

The Registry of this court shall allow the claimant to withdraw the same after

proper verification and strictly following the procedure laid down in this regards.
