Heard Mr. J. Sarma, learned counsel for the applicant. Also heard Ms. G. Sarma, learned standing counsel, N.F. Railway appearing for the opposite party.

This I.A. has been filed with a prayer to correct a typographical error occurring in the order dated 17-06-2022 passed by this Court in W.P.(C) No. 7360/2021 wherein the number of the contract agreement has been mistakenly referred to as CON/LMG-SLC/1858D whereas the correct contract agreement number according to the applicant is CON/LMG-SCL/1858 dated 14-10-2014. According to Mr. Sarma the second contract agreement is numbered as CON/LMG-SCL/1859 dated 15-10-2014.

Since the correction sought for by the applicant is not opposed by the learned standing counsel, N.F. Railway, the same stands allowed.

The correct contract numbers appearing in the order dated 17-06-2022 shall be read as Contract Agreement No. CON/LMG-SCL/1858 dated 14-10-2014 and Contract Agreement No. CON/LMG-SCL/1859 dated 15-10-2014.
