ORDER

Heard Mr. S. Sahu, learned counsel for the writ petitioner.

The writ petitioner claims to have purchase a plot of land measuring 1K-15L covered by Dag No. 1110 (New)/ 402 (Old) situated at Hengrabari, Patharquary under Beltola mouza. According to the writ petitioner, he had purchased the possessory right of the land on 09-05-2008. Apprehending eviction from the said plot of land, the instant writ petition has been filed.

Mr. S. Bora, learned standing counsel, GMDA and Mr. D.K. Sarma, learned Addl. Sr. Govt. Advocate, Assam submits that the writ petition has been filed merely on

apprehension and hence, the same is not maintainable in law.

Be that as it may, considering the facts and circumstances of the case as well as the materials available on record, without commenting on the claim of right over the land made by the petitioner, this writ petition is being disposed of at the motion stage by providing that the respondents shall not evict the petitioner from the land, without following the due process of law.

The writ petition stands closed.
