Heard Mr. S. Islam, learned counsel for the applicant. Also heard Ms. S.H. Bora, learned Additional Public Prosecutor for the State/respondent.

The present application has been filed under Section 363 of Cr.P.C. for extension of time to appear the applicant before the investigating officer in connection with an order passed by this Court on 25.11.2022 in AB No. 3493/2022.

It is submitted by the learned counsel for the applicant that the present applicant was asked to appear before the investigating officer within 10 days from the date of passing of the order dated 25.11.2022. But the applicant could not appear before the investigating officer as because an another case was pending before the Id. Sessions Judge, Tinsukia and he had to attend as such, he was not in a position to appear before the investigating officer within 10 days as per order of this Court on 25.11.2022. Therefore, he prays for some more time to appear before the investigating officer as directed by this Court on 25.11.2022 in AB No. 3493/2022.

On the other hand, the learned Addl.P.P. has no objection if the

prayer of the applicant is allowed.

In view of above, the applicant is directed to appear before the investigating officer within 7 days from today in connection with an order passed by this Court on 25.11.2022 in AB No. 3493/2022.

Interim order, passed on 25.11.2022, stands extended till such appearance before the investigating officer.
