<u>ORDER</u>

31.10.2022

- 1. This is a petition under Section 227 of the Constitution of India filed by the petitioner seeking a direction upon the Presiding Officer MACT, Srinagar to accept the amount transferred by court of Judicial Magistrate 1st Class Tangmarg in terms of order dated 20.07.2022 and to release the claim amount in favour of the claimant/respondent herein.
- 2. It appears that when the vehicle belonging to the petitioner suffered an accident, the same was released by the learned Judicial Magistrate 1st Class, Tangmarg on 14.08.2021 subject to the condition of deposition of Rs. 3.00 lacs in cash or furnishing of bank guarantee. Pursuant to aforesaid order, the amount seems to have been deposited by the petitioner before the Judicial Magistrate, which was kept in fixed deposit. As per the order of the Judicial Magistrate, the said amount was to be deposited with the concerned Claims Tribunal. Record further shows that the claim petition filed by the respondent against the petitioner has been

settled before the Lok Adalat on 25.06.2022 and a sum of Rs. 2.00 lacs

has been awarded in favour of the respondent. In terms of order dated

the learned Magistrate has directed that the amount

deposited with the said court to be transferred to the account of MACT

Srinagar for satisfaction of the claim.

3. Learned counsel for the petitioner has submitted that the Presiding

Officer of the MACT Srinagar is not releasing the amount in favour of

the claimant/respondent and he has not accepted the amount that has been

transferred into the account of said Tribunal.

4. Having regard to the limited nature of the controversy involved in this

case, the same can be disposed of by passing an appropriate direction to

Presiding Officer of MACT, Srinagar.

5. Accordingly the Presiding Officer of the MACT, Srinagar is directed to

accept the amount that has been transferred to it by the Judicial

Magistrate 1st Class, Tangmarg and thereafter release the claim amount in

favour of the rightful claimant. After satisfaction of the claim, if any,

balance amount remains, the same shall be released in favour of the

petitioner.

6. Disposed of as above.

7. Copy of this order be sent to the MACT Srinagar.
