**ORAL ORDER**

1. The present petition is filed by the petitioner seeking for following reliefs:

“(A) YOUR LORDSHIPS be pleased to issue appropriate writ, order or direction, directing the respondents take action against concerned accused persons in pursuance to written complaint dated 16/07/2020 and 21/10/2019 (Annexure-A colly) and take all necessary steps against accused persons in accordance with law including arrest of accused, etc., in the interest of justice;

(B) YOUR LORDSHIPS be pleased to issue appropriate

writ, order or direction, directing the respondents give explanation for their inaction in pursuance to written complaint dated 16/07/2020 and 21/10/2019 (Annexure-A colly), in the interest of justice;

(C) YOUR LORDSHIPS be pleased to direct the respondents to produce Action Taken Report before this Hon'ble Court, in pursuance to written complaint dated 16/07/2020 and 21/10/2019 (Annexure-A Colly), pending the admission, hearing and final disposal of this petition;

(D) YOUR LORDSHIPS be pleased to pass such other and further order as the nature and circumstances of the case may be required;"

2. Heard learned advocate Mr. Mahendra Vora for learned advocate Ms. Archanaben B. Goswami for the petitioner, learned AGP Ms. Jyoti Bhatt for the respondent Nos.1 & 3, learned advocate Mr. R.B. Thakor for the respondent No.4.

3. Today, after arguing for some time, learned advocate Mr. Vora has submitted that though the respondent authority has considered his earlier

representation dated 27.10.2020 but he is not satisfied with that, therefore, he wants to make fresh representation before the concerned authority, therefore, he is not pressing the present petition.

4. Considering the request, it is appropriate to direct the petitioner to make appropriate representation before the respondent authority within a period of two weeks from today. If such representation is made, the authority concerned shall decide the same, as expeditiously as possible, preferably within a period of six weeks thereafter, after considering the materials available on the record, by keeping in mind the principles of law as well as provisions of law.

5. With the above direction, the present petition is **disposed of**, as not pressed. Notice is discharged. Direct service of the order is permitted.
