

THE HON'BLE Dr. JUSTICE K. MANMADHA RAO

CRIMINAL PETITION No.3233 2022

ORDER:-

This petition is filed under Section 438 of the Code of Criminal Procedure, 1973, to enlarge the petitioners on bail in the event of their arrest in relation to Crime No.227 of 2018, dated 08.10.2018 of Tadipatri Rural Police Station, Ananthapuramu District, registered for the offences under Sections 147, 148, 506, 307 read with 149 of the Indian Penal Code, 1860 and under Section 3(1)(r) and 3 (1) (s) of the Scheduled Castes and the Scheduled Tribes (Prevention Of Atrocities) Act, 1989.

2. Heard learned counsel for the petitioners and the learned Additional Public Prosecutor for the State.

3. Learned counsel for the petitioners would submit that none of the offences do not attract to the petitioners as they would not present at the scene of offence. Hence, they would pray for grant of anticipatory bail to the petitioners.

4. Learned Additional Public Prosecutor opposed the criminal petition and would submit that investigation in this case is pending for examination of some more witnesses. So, they would submit that the petitioners are not entitled to anticipatory bail.

5. In view of the submission made by learned counsel for the petitioners and learned Additional Public Prosecutor, this Court is inclined to grant bail to the petitioners, on some conditions.

6. In the result, the Criminal Petition is disposed of. The petitioners are directed to surrender before the Station House Officer, Tadipatri Rural Police Station, Ananthapuramu District, within 15 days from the date of this order. On such surrender, the petitioners shall be released on bail on their executing personal bond for a sum of Rs.25,000/- (Rupees twenty five thousand only) each with two sureties for a like sum each to the satisfaction of the Station House Officer, Tadipatri Rural Police Station, Ananthapuramu District and the petitioners shall appear before the S.H.O., Tadipatri Rural Police Station on every Saturday between 10.00 am and 11.00 am till filing of charge sheet. Further, on such release, the petitioners shall abide by the conditions mentioned under Section 438(2) of Cr.P.C as under:

- 1) The petitioners shall make himself available for interrogation by a police officer as and when required.
- 2) The petitioners shall not directly or indirectly make any inducement, threat or promise to any person acquainted with the facts and circumstances of the case so as to dissuade him from disclosing such facts to the Court or to any police officer.
