ORDER:-

This Criminal Petition under Section 482 of the Code of Criminal Procedure, 1973 (for short "Cr.P.C.") is filed to quash the Proceedings in Crime No.39 of 2018 of Proddatur II Town Police Station, Kadapa District.

2. Heard learned counsel for the petitioner and the learned Additional Public Prosecutor for the State.
3. At the time of hearing, learned Assistant Public Prosecutor submits that the police, after investigation, laid the charge sheet and is pending adjudication *vide* C.C.No.257 of 2019, hence the cause in the present Criminal Petition does not survive and may be dismissed this petition as infructuous
4. Recording the said submission, the Criminal Petition is dismissed as infructuous.


