### **JUDGEMENT**

Both appellant and respondent along with their respective counsels are present and filed the compromise petition.

- 2. Both the parties stated that they understood the terms of the compromise recorded in compromise petition.

  Terms of the compromise as recorded in the petition are as follows:
  - filed 1. The appellant has case by challenging the exparte decree of divorce passed by the Family Court in M.C.No.59/2016 on 03.02.2017, now the appellant and the respondent both have compromised by mediation of elders of village and agreed to live together along with children.

- 2. The respondent undertakes not to pickup quarrel with appellant for any reason and to maintain his wife and children with dignified manner.
- 3. The appellant also undertakes not to pickup quarrel with respondent for any reason and to maintain her husband and children with dignified manner.
- 4. The appellant wants to withdraw the Criminal Misc.No.229/2019 and Criminal Misc.No.109/2017 are pending on family Court, Gadag in view of this compromise arrived between the appellant and respondent.
- 3. It is found that the compromise is valid and legal and parties have entered into that knowing fully well the consequences of the same.
