<u>ORDER</u>

- 1. The prayer in this writ petition is for issuance of a mandamus to direct the second respondent to consider the representation submitted, vide Annexure-E.
- 2. By Annexure-E, the petitioner is seeking for grant of the land. The petitioner contends that the proposal for grant in favour of the petitioner was initially for an extent of 3 guntas 2 annas but only 1,400 sq. ft. had been granted and the petitioner` is therefore seeking for grant of the remaining land as per Annexure-E.
- 3. Since the petitioner contends that he was already held entitled to be granted 3 guntas 2 annas as per the initial proposal, it would be necessary to direct the second respondent to consider the request of the petitioner in accordance with law.
