This writ petition is filed under Articles 226 & 227 of the Constitution of India, praying to direct the respondents to consider the representation filed by the petitioner before the respondents for the appointment of Assistant Teacher while considering the service of the petitioner Honorary in the School of 5th & 6th respondent in the ends of justice, law and equity.

2. This petition was dismissed for non-prosecution on 24.06.2019. Thereafter, IA-1/2019 was filed with a prayer to recall the order dated 24.06.2019 and this Court, on 15.06.2022, had allowed the said application and granted two weeks time to comply with the office objections subject to the condition that the petitioner shall pay a sum of Rs.500/- as cost to the Advocates' Library Fund, High Court of Karnataka, Kalaburagi Bench. However, neither the cost has been paid nor the office objections have been complied with. Under the circumstances, this Court has no option but to dismiss the petition for non-prosecution. Accordingly, petition is dismissed for non-prosecution.
