THIS PETITION IS FILED UNDER ARTICLE 227 OF THE CONSTITUTION OF INDIA PRAYING TO DIRECTING THE LEARNED SR. CIVIL JUDGE AND JMFC, ANEKAL TO PASS ORDER ON IAS1 AND 2 IN OS NO.831/2016 FILED BY RESPONDENT 1 TO 3 AGAINST THE PETITIONER AND OTHERS, WITHIN A PERIOD TO BE PRESCRIBED BY THIS HONBLE COURT, ALLOW THIS WRIT PETITION WITH COSTS AND GRANT SUCH OTHER RELIEFS AS THIS HONBLE COURT DEEMS FIT TO GRANT IN THE CIRCUMSTANCE OF THE CASE.

THIS PETITION COMING ON FOR ORDERS THIS DAY, THE COURT MADE THE FOLLOWING:

ORDER

As only a mandamus is sought, the writ petition is taken up for disposal without notifying the

respondent as no prejudice would be caused to respondent.

- 2. The captioned writ petition is filed seeking seeking a writ of mandamus to direct the learned Judge to decide the application filed in I.A.No.1 filed under Order XXXIX Rule 1 and 2 of CPC in O.S.No.831/2016.
- 3. The plaintiffs filed a suit for partition and separate possession. The learned counsel for the present petitioner-defendant No.11 submits that the parties to the suit have advanced their arguments and have rather concluded their arguments on 20.3.2021. The grievance of the petitioner is that though the parties have concluded their arguments on I.A.No.1 way back in March 2021, the learned Judge has not decided the same. The grievance of the petitioner is that the learned Judge instead of passing orders on

the said application is extending the interim order from time to time.

4. Perused the order sheet and examined the material on record. The learned Judge cannot go on extending interim order without deciding I.A.No.1 as held by the Apex Court in the case of **Asian Resurfacing of Road Agency .vs. Central Bureau of Investigation**¹. In the light of the principles laid down by the Apex Court, this Court is of the view that mandamus issues in the present case on hand. Though this Court has to be cautious and reluctant in issuing mandamus to the Courts below, this is a fit case where mandamus issues as the learned Judge is extending interim order in contravention of the directions issued by the Apex Court in the case cited supra.
