THIS WRIT PETITION IS FILED UNDER ARTICLES 226 AND 227 OF THE CONSTITUTION OF INDIA, PRAYING TO CALL FOR THE RECORDS WHICH ULTIMATELY RESULTED IN OPENING A ROWDY SHEET AGAINST THE PETITIONER; AND DIRECT THE R-2 TO R-5 TO DELETE THE NAME OF THE PETITIONER FROM THE LIST OF ROWDY SHEET MAINTAINED IN THEIR RECORDS AGAINST THE PETITIONER.

THIS WRIT PETITION COMING ON FOR PRELIMINARY HEARING, THIS DAY, THE COURT MADE THE FOLLOWING:-

ORDER

Learned counsel for petitioner in this petition is seeking a writ of mandamus directing respondent Nos.1 to 5 to delete the name of petitioner from the list of rowdy-sheeters maintained in the records of respondent Nos.2 to 5 against the petitioner.

2. Learned High Court Government Pleader has filed a memo along with the documents showing that the name of the petitioner has been deleted from the records and the relevant portion of the order reads as under:
