<u>ORDER</u>

Office objection regarding maintainability of writ petition is upheld.

2. The captioned writ petition is filed by the petitioner assailing the order of the trial Court passed on an application filed under Order XXXIX Rule 1 and 2 of CPC. By allowing the application, trial Court has granted injunction which is an appealable order under Order XLIII of CPC. Therefore, writ petition is not maintainable.

Accordingly, writ petition is dismissed.

However, liberty is reserved to the petitioner to move appropriate application before the trial Court and seek appropriate order. Liberty is also reserved to seek advancement. If, such an application is filed, trial Court shall expedite the matter and decide the application after notifying both the counsel.
