ORDER

The petitioner has approached this Court, challenging the order of eviction dated 22.07.2016, Annexure P-2, passed by the Collector-cum-ACF Nahan, District Sirmour, from the land, which is part of reserved forest land and also the order dated 28.04.2021, Annexure P-1, passed by the Divisional Commissioner, Shimla Division Shimla-2, dismissing the appeal filed against the said order of eviction.

2. The learned counsel for the petitioner in the course of arguments has relied on the orders passed by this Court in CWP No.846 of 2019, titled as Surtu Versus State of Himachal Pradesh and others, dated 24.04.2019 and CWP No.2330 of 2018, titled as Prem Singh Versus State of Himachal Pradesh and others, dated 22.10.2018. He has argued that both these matters were disposed of by granting liberty to the petitioners therein to move the appropriate application(s) before the

competent authority, within two weeks, who shall thereafter

determine the claim of the petitioner, by passing a speaking

order, within a period of four months.

3. Even though, on the perusal of the order passed

by the appellate authority, we do not find any error in the

same, but at the request of the learned counsel for the

petitioner, we dispose of the writ petition and set the petitioner

at liberty to move an application before the competent

authority on the prescribed format, within a period of two

weeks from today, who shall pass a speaking order on the

same, within a period of four months thereafter.

4. The pending miscellaneous application(s), if any,

shall also stand disposed of.
