This petition coming on for admission this day, **Hon'ble**Ms. Justice Sabina, passed the following:

ORDER

Petitioner has filed the petition under Article 226 of the Constitution of India, seeking following relief:-

- "a). That respondents may kindly be directed to transfer the petitioner from present place of posting to some place of choice mentioned in para 5 (supra) without any condition of substitute"
- Learned counsel for the petitioner has submitted that the petitioner has completed his normal tenure in the difficult sub-cadre area and is now entitled for his transfer to a soft area, in terms of the transfer policy dated 10th July, 2013. Representation dated 13th October, 2021 (Annexure P-4), moved by the petitioner in this regard to the respondents has not been decided so far.
- **3.** Learned Additional Advocate General has submitted that the representation moved by the petitioner is not in terms of the transfer policy dated 10th July, 2013.
- **4.** Accordingly, without adverting to the merits of the case, this writ petition is disposed of with a direction that in case the petitioner moves a fresh representation to the respondents, in terms of

the transfer policy, dated 10th July, 2013, within a week from today, then respondents shall dispose of the same within two weeks of the receipt of the representation, in accordance with law.

Pending application(s), if any, also stand disposed of.
