These petitions coming on for hearing this day, the Court passed the

JUDGMENT

By way of these writ petitions, the petitioners have prayed for issuance of directions to the respondents to acquire their lands as also

houses after paying compensation alongwith interest on the ground that in the case of construction of National Highway, their houses/lands have been damaged.

2. Today, Mr. K. D. Shreedhar, learned Senior Counsel, appearing for the National Highway Authority of India has submitted that in the entire State where National Highways are being constructed, there are disputes pertaining to the alleged damage caused to the structures/lands of people outside the "Right of Way". To determine the genuineness of the claims, in all Districts, the State of Himachal Pradesh constituted Committees headed by the concerned Deputy Commissioner. This was done in terms of Notification dated 8th June, 2022, which otherwise is on record. Learned Senior Counsel further stated that the claims received either by the National Highway Authority of India or Competent Authority for Land Acquisition were referred to this Committee. The damage was assessed by the Committee and thereafter, the report of assessment was forwarded to the Head Office of National Highway Authority of India. Learned Senior counsel further stated that now the Head Office has made its own assessment with regard to the damages which are payable to the petitioners and in case the petitioners are willing to accept the compensation so assessed, then the same can be paid to them by putting a quietus to these litigations. Learned Senior Counsel further submitted that this will be full and final settlement of the claims of the petitioners as far as National Highway Authority of India is concerned. Learned Senior Counsel while drawing the attention of the

Court to the latest compliance affidavit which has been filed in the cases by the Deputy Commissioner, Mandi has submitted that in terms of communication dated 14th May, 2022 addressed to the Deputy Commissioner, the approved proposal of damages stands conveyed to the

3. Learned counsel for the petitioners submitted that he has

instructions to state that the petitioners are willing to put a quietus to these

litigations by accepting the damages as have been assessed by the

National Highway Authority of India.

Commissioner.

4. In view of what has been discussed above, without going into

the merits of the issues raised in the present petitions, the same are ordered

to be closed by directing that as agreed, the damages as have been

assessed by the NHAI, be released in favour of the petitioners as

expeditiously as possible and not later than 31st August, 2022, in their bank

accounts, details whereof shall be provided by them to the office of the

Deputy Commissioner and receipt of the same by the petitioners shall be as

full and final acceptance of whatever compensation was due to them from

the National Highway Authority of India. Interim orders, if any, also stand

vacated forthwith. Miscellaneous applications, if any, also stand disposed of.
