THIS REVIEW PETITION HAVING COME UP FOR ADMISSION ON 28.02.2022, THE COURT ON THE SAME DAY DELIVERED THE FOLLOWING:

#### ORDER

This petition, seeking review of the judgment of this Court dated 11.10.2021, has been filed conceding that the survey as ordered by this Court has now been completed; but contending that in the report settled pursuant thereto, certain portions of the properties of the petitioner have been illegally included in the extent claimed by the respondent - Bank.

- 2. I have heard Sri.N.M.Madhu, learned counsel for the petitioner and Smt.K.Amminikutty, learned Senior Government Pleader appearing for the official respondents.
- 3. Smt.K.Amminikutty submitted that though survey has been completed, the resultant sketch has not been issued to any of the parties and therefore, that this review petition is totally without purpose. She added that, in any event, if the review petitioner has any cause against the survey or the sketch to be issued, his remedy is to approach the competent Authorities or the Civil Court for proper redress.
- 4. I must say that there is some force in the submissions of the learned Senior Government Pleader because this Court had only directed the Head Surveyor to take up Ext.P6 representation of the writ petitioner, produced in the writ

petition, and to conduct a survey under the "Torrence Scheme". Obviously, therefore, if the review petitioner has any cause against the survey or the sketch to be issued, he certainly has remedies before the competent statutory Authorities or even before the Civil Court before which he says that a Civil Suit, is pending between himself and the 8<sup>th</sup> respondent.

5. In the afore circumstances, I do not think that it will be necessary for this Court to entertain this review petition and I, therefore, close it; however, leaving full liberty to the petitioner to invoke and pursue all remedies that may be available to him statutorily or before the competent Civil Court, for which purpose, all contentions are left open.

Needless to say, the judgment of this Court or the contents of this order will not prejudice the competent Civil Court or the statutory Authority, if and when the review petitioner approaches them for available remedies, from dealing with every aspect in terms of law.
