JUDGMENT

This writ petition is filed with following prayers:

- i. Issue a writ in the nature of Mandamus or any other writ, order or direction to the 1st respondent District Collector and Appellate Tribunal to consider Exhibit P6 (Appeal) and P7 (Stay Petition) in accordance with law after hearing the petitioners and pass appropriate orders thereon, expeditiously within a time limit to be fixed by this Hon'ble Court.
- ii. Stay the Direction No.3 in Exhibit P5 Order and to restrain the respondent Nos. 5 to 7 from forcefully shifting the 1st petitioner mother from the care of 2nd petitioner, until disposal of Exhibit P6 appeal.
- Direct the respondent Nos. 5 to 7 to provide iii. monthly maintenance to the 1st petitioner as sought for Exhibit Р3 application in for maintenance, until disposal of Exhibit P6 application.

iv. Issue such other appropriate writ, order or direction as this Hon'ble Court may deem just and fit in the circumstances of the case.

2. Petitioners suffered with Ext.P5 order. Aggrieved by the same, the petitioners filed Ext.P6 appeal and P7 stay petition. The grievance of the petitioners is that the appellate authority is not considering the appeal and stay petition and in the meanwhile, based on Condition No.(3) in Ext.P5, coercive steps are going to be taken. This Court perused condition No.(3) in Ext.P5. I do not want to make any observation about the merit of the case. Since the appeal and stay petition are pending before the appellate authority, I think there can be direction to the appellate authority to consider the appeal within a time frame and till then, condition No.(3) in Ext.P5 can be kept in abeyance. In this writ petition, notice is not issued to respondents 3 to 8. If they are aggrieved by this judgment, they are free to file a review petition before this Court.

Therefore, this writ petition is disposed of in the following manner:

1. The 1st respondent is directed to consider and

pass appropriate orders in Exts.P6 and P7, as expeditiously as possible, at any rate, within one month from the date of receipt of a copy of this judgment.

- Till final orders are passed as directed above,
 Condition No.(3) in Ext.P5 order shall not be enforced.
- 3. It is made clear that this Court has not considered the matter on merit and the appellate authority is free to pass appropriate orders in accordance to law, after hearing all the affected parties.
