# **JUDGMENT**

By Annexure- A1 judgment, W.P.(C) No.21938 of 2020 was disposed of directing the 4<sup>th</sup> respondent to consider Ext.P16 application submitted by the petitioner in accordance with law, within a period of two months.

- 2. The petitioner in the Contempt of Court Case submits that no consideration was done by the 4<sup>th</sup> respondent as directed by this Court and Annexure-A2 is not in due compliance of the judgment.
- 3. I have heard the learned counsel for the petitioner and the learned Government Pleader.
- 4. The judgment was delivered on 13.10.2021. Subsequently, referring to the judgment, the respondent has passed Annexure-A2 order. In Annexue-A2 order, the respondent has taken a stand that the application for change in the nature of the property can be considered only after the land

is removed from the Data Bank.

5. Perusing Annexure-A2 order dated 13.12.2021, this Court is of the view that Annexure-A2 has been passed in due compliance of Annexure-A1 judgment. If the petitioner is aggrieved by the decision contained in Annexure-A2 order dated 13.12.2021, the petitioner will have to challenge the said order, in accordance with law. The Contempt of Court case will not lie against the respondent, in the circumstances.

Accordingly, the Contempt of Court Case is closed granting liberty to the petitioner to challenge Annexure-A2 order, in accordance with law.
