JUDGMENT**Alexander Thomas, J.**

We have heard both sides.

2. From the submissions of the parties, it is clear that the matter in issue is covered by the judgment dated 09.07.2019, rendered by the Division Bench of this Court in the case in ***Revathy V. S. v. Kerala Public Service Commission & Others*** [2019 (3) KHC 940], later confirmed by the subsequent final order dated 22.08.2019 rendered by the Division Bench in Review Petition, R.P. No.744/2019 (arising out of O.P.(KAT) No.168/2019).

3. The judgment of the Division Bench of this Court in **Revathy's** case (*supra*) rendered on 09.07.2019 in O.P.(KAT) No.168/2019 [2019 (3) KHC 940 = [2019 (3) KLT 359], reads as follows:-

"1. The recruitment is to the post of Laboratory Technical Assistant - Agriculture (Nursery Management and Oriental Gardening) in the Kerala Vocational Higher Secondary Education Department. The candidate having rank No.14 in the ranked list published by the Kerala Public Service Commission did not join duty as she got employment in the Agriculture Department. The candidate having rank No.15 also did not join duty as he had relinquished his claim for appointment in the requisite proforma which was accepted by the Kerala Public Service Commission.

2. The State Government at that point of time halted filling up of further vacancies till the implementation of the National Skill Qualification Frame Work in the Vocational Higher Secondary Schools. The ban order of the State can operate only in regard to filling up of future vacancies and not to the vacancies to which the candidates have already been advised for appointment. The order dated 09.05.2018 of the Education Department intimating the ban comes long after 19.03.2018 and 10.04.2018 which were the dates of reporting of vacancies and advise.

3. The following observations in Indian Bank v. Jayasree [1998 (2) KLT 464 (DB)] is apposite:

"It is not a question of any appointment of an existing vacancy or appointment in a fresh vacancy. Therefore, in our opinion the restrictions imposed by the Reserve Bank of India will not apply to the case on hand. In this case, the recruitment was already over. Out of the 15 candidates recruited, one did not join duty and this vacancy has to be treated as a non joining duty vacancy and therefore it is not a fresh vacancy."

(emphasis supplied).

The ban order would have little impact on the two candidates having rank Nos.14 and 15 had they joined duty in the normal course and the vacancies resultant on their refusal are not to be treated as fresh ones.

4. The petitioner who holds rank No.16 in the ranked list published by the Kerala Public Service Commission is the next eligible candidate to be advised for appointment to the vacancies. The Kerala Administrative Tribunal was not justified in observing that the policy of the State Government to keep in abeyance the selection process cannot be interfered

with. We set aside the impugned order of the Kerala Administrative Tribunal and direct the respondents to complete the process of appointment for vacancies that arose before 09.05.2018.

The original petition is allowed. No costs."

4. Subsequently, a review petition as R.P. No.744/2019 was filed in the abovesaid O.P.(KAT) No.168/2019 and the said review petition was filed at the instance of the original petitioner therein/original applicant. The Division Bench of this Court has rendered final order dated 22.08.2019 dismissing R.P. No.744/2019 in O.P.(KAT) No.168/2019 and the final order in the aforesaid review petition, R.P. No.744/2019, reads as follows:-

"We had relied on the judgment in Indian Bank v. Jayasree [1998 (2) KLT 464 (DB)] cited at the bar in the disposal of Revathy v. Kerala Public Service Commission [2019 (3) KLT 359 (DB)]. Mr. P.J.Elvin Peter, Advocate for the petitioner now submits that the judgment relied on has since been set aside in Civil Appeal Nos. 4054-4055/1999 by the Supreme Court on 22.11.2001. The decision of the Supreme Court is only to the effect that a vacancy which arose in a post as a result of non-joining of a candidate is a new open for fresh appointment.

2. The effect of a ban on appointment has been considered in a later decision by a larger bench in Govt. of Andhra Pradesh v. Sri. Sevadas Vidyamandir High School and others [(2011) 9 SCC 613]. The Supreme Court has categorically held therein that the ban order can only operate prospectively and not to the process of recruitment which had already commenced. It is the time of occurrence of the vacancy that should be relevant – whether it is after the ban or before - as in the case of promotion {see: Varghese v. State of Kerala [1981 KLT 458 (FB)]}.

3. The above view is in tune with Rule 14 of the Kerala Public Service Commission Rules of Procedure which obliges the Commission 'to advise candidates for all the vacancies reported and pending.' It can safely be concluded that the vacancies which arose upto 09.05.2018 which was the date of the order of the Government are not affected by the ban order and can be filled up. We also take note that the order dated 09.05.2018 has

been misconstrued as a ban by the Secretary of the General Education Department in his letter of intimation dated 14.06.2018.

The Review Petition is dismissed. No costs.”

5. Subsequently, the State of Kerala has preferred SLP (C) Nos.30379-30380/2019, to challenge the abovesaid verdict of the Division Bench in **Revathy’s** case (*supra*) and the Apex Court has rendered final order dated 01.09.2021, dismissing those SLPs and directing compliance of the directions issued by this Court in **Revathy’s** case (*supra*). A copy of the abovesaid final order dated 01.09.2021, rendered by the Apex Court dismissing the abovesaid SLP (C) Nos.30379-30380/2019, arising out of the aforesaid O.P.(KAT), has been produced as Ext.P5 in O.P.(KAT) No.290/2019.

6. Thus, it can be seen that the Division Bench of this Court in **Revathy’s** case (*supra*), has held that the stand of the State Government that none of the vacancies can be filled up on account of the proposed change of curriculum in the Vocational Studies in relation to the aforesaid post in question, on the basis of the recommendations of the Central Authority, is not fully justifiable and that the ban order was imposed by the State Government as per G.O.(MS) No.56/2018/G.Ed. dated 09.05.2018, and that all substantive vacancies in the abovesaid post, which has arisen before 09.05.2018

(the date of issuance of the ban order as per the above G.O. dated 09.05.2018), could be utilised for direct recruitment by advice and appointment of candidates included for the abovesaid post in question in the rank list published by the PSC. In other words, vacancies, which have arisen on or after 09.05.2018, i.e., the date of issuance of the ban order, cannot be utilised for direct recruitment on the basis of the abovesaid selection process , etc.

7. Hence, the abovesaid conclusion arrived at by the Division Bench of this Court in **Revathy's** case (*supra*), that substantive vacancies in the abovesaid post in question, which have arisen before 09.05.2018 (the date of issuance of the ban order imposed by the Government as per G.O. dated 09.05.2018), could be utilised for the abovesaid selection process in question and the same has become final with the dismissal of the SLPs filed at the instance of the State, as mentioned hereinabove.

8. Hence, it is ordered and declared that the matter in issue is covered by the abovesaid directions issued by the Division Bench of this Court in **Revathy's** case (*supra*), inasmuch as all vacancies, which have arisen before 09.05.2018, could be utilised for the abovesaid selection process in question.

9. However, we are told by the learned Standing Counsel for the Kerala Public Service Commission as well as by all the Advocates concerned, that the maximum period of 3 years of all these rank lists in question has expired on various dates in the year 2019 or so. We are told that, in some of the cases, vacancies could have been provisionally reported by the appointing authority, to the PSC concerned, for some of the posts in question before the expiry and such vacancy requisition report of provisional vacancies would have reached the PSC office before the expiry of the 3 year period of the rank list in question.

10. We are told by Sri.P.E. Sajal, learned counsel appearing for the petitioner in O.P.(KAT) No.520/2019, that an interim order was passed by this Court on 12.12.2019 directing the appointing authority to provisionally report 2 vacancies in the post of Laboratory Technical Assistants by the appointing authority so that the said vacancy requisition report of such provisional vacancies should reach the PSC office on or before 13.12.2019 (expiry of the 3 year period from the finalisation of the said rank list in question) and that the said vacancy requisition report had actually reached the PSC office, in respect of the said vacancies for the abovesaid post, before the expiry of the said 3 year maximum currency period of the rank list in question.

11. We need not get into those factual issues except to say that if any vacancy requisition report has been received by the PSC before the expiry of the rank list, in respect of provisional vacancies, on account of compliance of directions issued by the Tribunal or this Court and such vacancy requisition report of provisional vacancies has not been utilised for advice and are kept pending for want of clarification or due to pendency of this case, etc., then the PSC authorities concerned will immediately seek clarification from the appointing authority concerned as to whether the said provisional vacancies are, in fact, substantive vacancies, which have arisen before 09.05.2018 and if it is found that such vacancy requisition report styled as provisional vacancies are, in fact, substantive vacancies in the post in question, which has arisen before 09.05.2018 and such vacancy requisition report has reached the PSC before the expiry of the 3 year maximum period of of the rank list, etc., then the PSC authorities will ensure that necessary steps are taken for advice of candidates included in the said rank list, notwithstanding that the 3 year period may be over.

12. What remains are the matters in O.P.(KAT) Nos.447/2019, 521/2019, 522/2019, 523/2019, 526/2019, 528/2019, 529/2019, 534/2019, 254/2020, 399/2020, 13/2021 & 146/2021, etc., filed at the

instance of the Kerala Public Service Commission, wherein the Tribunal, while holding that no directions can be issued for making advice and appointments from the abovesaid rank list in question in view of the abovesaid ban order of the State Government to impose the ban as per G.O. dated 09.05.2018, etc., ordered that the Kerala Public Service Commission shall exercise the discretionary power conferred in terms of the 5th proviso to Rule 13 of the Kerala Public Service Commission Rules of Procedure and should extend the rank list until the State Government takes a policy decision on the question as to whether appointment could be made from the abovesaid rank list, etc.

13. Now the matter in issue is concluded by the findings and orders of the Division Bench of this Court in **Revathy's** case (*supra*), which has been confirmed by the Apex Court, as well and there is no question of extension of the rank list. Moreover, it is well established that the extension of the ranked list can be considered even by the PSC only if it is done before the expiry of the maximum currency period of the rank list in question (see **Thulaseedharan v. KPSC** [2007 (3) KLT 19 (SC)]). Further, it is also trite that matters relating to extension of the rank list on account of such proviso, etc. is a matter which would fall eminently within the domain of the PSC authorities.

14. In view of the abovesaid aspects, we are not in a position to sustain the abovesaid directions issued by the Tribunal. Hence, the abovesaid direction issued by the Tribunal directing the PSC to extend the rank by recourse to the powers under the 5th proviso to Rule 13 of the Kerala Public Service Commission Rules of Procedure, until the Government takes a decision, etc., will stand set aside. Hence, the directions and orders rendered by the Tribunal as per the final orders in these original applications will stand modified and substituted as above.

15. Further, in the light of the abovesaid concluded directions issued by the Division Bench of this Court in **Revathy's** case (*supra*), it is ordered that if substantive vacancies which have arisen before 09.05.2018 have been duly reported to the PSC, the vacancy requisition report of which has reached the PSC office before the expiry of the 3 year maximum period of the rank list and such vacancy has been kept pending for advice due to the abovesaid disputed issues, then the PSC, if necessary, may ascertain from the appointing authority as to whether the vacancy in question has arisen before 09.05.2018 and if it is found so, advice may be made as against such vacancies which have arisen before 09.05.2018, so long as such vacancy requisition report has been

received by the PSC before the expiry of the rank list.

With these observations and directions, the above original petitions will stand disposed of.
