**AWARD**

Compensation Awarded by the Lower Court.	Rs.5,77,400/- (Rupees Five lakhs seventy-seven thousand and four hundred only) with proportionate costs and interest at 7.5% per annum from the date of the petition till date of realization to the petitioner.
Compensation Awarded (Settlement Reached) in the Lok Adalat.	In addition to the amount already deposited, the Insurance Company has agreed to deposit Rs.6,50,000/- (Rupees Six lakhs fifty thousand only) towards full and final settlement. In the event of default or delay in making such deposit, the amount payable shall carry interest at 12% per annum from the date of default. The Claimant/Appellant/Petitioner is present and agreed to receive the said amount towards full and final settlement of his claim.
Apportionment of Compensation, if any	---



**Additional Direction(s):**

1. The Appellants are entitled to the refund of Court Fee paid in this appeal.
2. The amount already deposited by the Insurance Company shall be given credit to.
3. Upon such deposit by the Insurance Company, the Claimant/Appellant/Petitioner is permitted to withdraw the entire amount.




In token of consent for the above settlement and award, the parties and their counsel have signed this award in our presence.
