**JUDGMENT:** *(per Justice G. Sri Devi)*

The *lis* in this Appeal preferred by the Land Acquisition Officer-cum-Special Deputy Collector, L.A. Unit, R.L.I.S.P.-II, Pebbair, Mahabubnagar District, is directed against the order passed by the civil Court in the reference made under Section 18 of the Land Acquisition Act, 1894.

2. Brief facts of the case are that different extents of lands owned by the claimants situated in Kalwarala Village of Pangal Mandal were acquired by the Government for forming embankment including CD & CM works of D-23 from KM 4.873 to KM 11.885 from Shankarasamudram Balancing Reservoir by issuing draft notification under Section 4 (1) of the Land Acquisition Act, 1894 (for short "the Act") on 16.05.2013 followed by draft declaration. After due enquiry, the L.A.O. has passed an award, dated 04.11.2013, fixing the market value of the acquired land at Rs.55,000/- per acre for dry lands, Rs.60,000/- per acre for Jalutari lands, Rs.65,000/- per acre for irrigated dry lands and Rs.70,000/- per acre for wet lands.

Not satisfied with the said compensation, the claimants have sought for reference under Section 18 of the Act, seeking enhancement of the compensation. The reference Court, by an order, dated 23.11.2015, has fixed the market value of the acquired land at Rs.4,00,000/- per acre for dry lands and Rs.4,05,000/- per acre for jaluthari lands, Rs.4,10,000/- per acre for dry irrigated land and Rs.4,15,000/- per acre for wet land. Challenging the said enhancement, the Land Acquisition Officer has preferred the present appeal.

3. Heard Sri D.Kiran, learned Assistant Government Pleader for the Appeals for the appellant and learned counsel for the claimants. Perused the material available on record.

4. As seen from the record, the present acquisition was for the purpose of ancillary project of Sankara Samudram Balancing Reservoir and the land was acquired in the year 2013. In respect of acquisition of lands in adjacent villages, which were earlier acquired for similar purpose, this Court *vide* judgment, dated 15.09.2022 has already elaborately analysed the evidence and considered the identical issue raised in the appeal in L.A.A.S.No.111 of 2019 and batch. Both the counsel have not disputed the factum of commonality of the evidence

and the issue in this appeal and in L.A.A.S.No.111 of 2019 and batch, wherein this Court has dismissed the appeals filed by the L.A.O. confirming the market value fixed by the reference Court at Rs.4,00,000/- per acre for dry land; Rs.4,05,000/- per acre for Jaluthari lands and Rs.4,10,000/- per acre for wet land.

5. Since it is agreed on either side that the reasoning adopted by this Court in its judgment dated 15.09.2022 holds good even in this appeal, we dismiss this appeal confirming the market value fixed by the reference Court.

6. Accordingly, the appeal is dismissed confirming the order dated 23.11.2015 passed in O.P.No.43 of 2015 on the file of the Senior Civil Judge, Wanaparthy. However, the claimants are entitled for all the statutory benefits as per the amended Act. No order as to costs.

Miscellaneous petitions, if any, pending in these appeals shall stand closed.

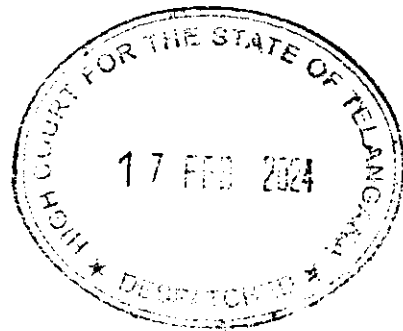


